Suit for permanent injunction restraining the
defendant from getting elected the office bearers of
Bhagwan Shri Krishna College of Education Mandi Babwali,
which is a separate Registered Society, (registered with
the Registrar of Societies, Haryana, Chandigarh, at No. 83,
on 15.12.1976) from the members of the Haryana Education
Society, Mandi Babwali on 15.02.1981 as per oral and docu-
mentary evidence of all kinds.

Plaint presented on 10.2.1981

This suit coming on this day for final disposal
before me (C.R. Goel, HCS., Sub Judge 1st Class, Babwali) in the
presence of Shri S. C. Gupta Advocate for the plaintiff and
defendant in person.

It is ordered that in view of the compromise Ex. B
XX, I hereby pass a decree for permanent injunction, in
favour of the plaintiff and against the defendant, merely
restraining the defendant from getting elected the office-
bearers of Bhagwan Shri Krishna College of Education, Mandi
Babwali, which is a separate registered society with the
Registrar of Societies, Haryana, Chandigarh. Parties shall
be bound by the terms and conditions of the compromise Ex.
XX, wherein it has been mentioned that the management of
the college shall be in the hands of the plaintiff.

College of Education and Shri Nanak Chand Aggarwal
Advocate is the president of the said College Society,

and the Haryana Education Society, of which the
defendant is a president, has spent Rs. 132000/- on the

construction of the building of Bhagwan Shri Krishna
College of Education and it has agreed to pay the same

to the Haryana Education Society, in monthly equal
instalments, which will start from April 1931, and
thereafter every month regularly and all the furnitures,

fictures, fans, office equipments and the College building
belongs to the said college of Education and the record
of the same has been handed over to the principal

Smt. P. P. Singh and henceforth Haryana Education Society
shall have no concern with Bhagwan Shri Krishna College
of Education (for women) at Mandi Bahwal and it is also

mentioned therein that all bills pertaining to Bhagwan
Shri Krishna College of Education (for women), prior
to this date, shall be paid by the Haryana Education
Society and all amounts lying to the credit of Bhagwan

Shri Krishna College of Education (for women) Mandi Bahwal,
anywhere in bank etc., or cash in hand in the books,
belongs to the Bhagwan Shri Krishna College of Education

(for women), as mentioned in detail in the said
compromise. parties are, however, left to bear their own
costs of the present suit, as agreed upon by them.

6. All bills pertaining to Bhagwan Shri Krishna College of Education (for women) prior to this date will be paid by Haryana Education Society. All amounts lying to the credit of Bhagwan Shri Krishna College of Education

(for women), Mandi Bahwali any where in Bank etc. or cash in hand in the books belong to Bhagwan Shri Krishna College of Education (for women).
